

CPI – Seasonally Adjusted – the consumer price index is a commonly used measure of inflation S&P 500 Composite – represents the large-cap U.S. stock market and comprises the largest 500 companies weighted by market cap S&P 400 Mid-Cap – represents the mid-cap U.S. stock market and comprises the next 400 companies by market cap beneath the S&P 500, weighted by market cap Russell 2000 – represents the small-cap U.S. stock market and comprises 2000 companies on the U.S. stock exchanges weighted by market cap MSCI EAFE Net – represents the large-cap and mid-cap stock market across developed market countries, excluding the U.S. and Canada MSCI Emerging Markets (EM) Net – represents the large-cap and mid-cap stock market across 23 emerging market countries Bloomberg Barclays U.S. Aggregate – represents the U.S. dollar denominated long-term tax-exempt bond market Wilshire Liquid Alternative Index – broad measure of the liquid alternatives market, combining performance of five strategy types: hedged equity, global macro, relative value, multi-strategy and event driven
