A Letter from the Chair

As I reflect on the first six months of my term as chair of the Board of Directors for the Community Foundation of the Ozarks, I am left contemplating how my professional and philanthropic experiences are deeply intertwined. In both spaces, I am surrounded by people who are committed to service, stewardship and community strength.

In my career with Associated Electric Cooperative Inc., our mission is simple but essential — to provide reliable, affordable and responsible energy to our member cooperatives across Missouri and beyond. Behind that mission are families, farmers, small-business owners and the like, whose livelihoods depend on a consistent power supply every single day. 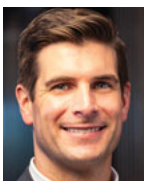

FY25 Action Plan Review

Develop Tiered Structure and Services for Constituents

The CFO continued refining its tiered service structure for affiliates, nonprofit agency partners and donor-created funds. Donor-advised fund tiers are now in place, with updated data to guide implementation for FY27. Agency partner tiers are active and being refined, while the affiliate framework remains in development. These efforts will help ensure equitable, transparent and scalable services across all constituent types.

Track Dollars Influenced as Benchmark

A new system to track “influenced dollars” — funds connected to community needs through CFO referrals or relationships — was implemented in FY25. The process has already identified an estimated \$1.07 million in influenced giving across 19 documented events as of June 2025, providing a benchmark for future years. The tracking and definitions will continue to evolve as the CFO refines how it measures the broader impact of its philanthropic connections.

Explore Constituent, Staff and Board Surveys

In partnership with Habitat Communication and Culture, the CFO launched an employee engagement survey in mid-2025, with a follow-up planned for early 2026. A full constituent survey is scheduled for completion by the end of 2025, while a board survey will be managed internally. These efforts support data-driven improvements in engagement, culture and governance.

Host Staff and Leadership Retreats

The CFO strengthened team cohesion and leadership alignment through a two-day staff retreat in August 2024. The leadership group also developed a new document outlining its own roles and responsibilities, providing greater clarity and accountability within the organization.



Move to 300 South Jefferson

Renovations began in January 2025 on CFO's new headquarters at 300 South Jefferson. Construction completed on time and under budget in July 2025, with staff moving into the new office in early August. The new location will enhance visibility and provide expanded space for collaboration and growth.

Implement New Organizational Chart

The CFO completed its two-phase organizational restructuring between spring 2024 and spring 2025. The new chart reflects refined reporting lines and supports the Foundation's growing scale and strategic needs.

Integrate New VP of Communications and Roll Out Communications Plan

Following the onboarding of the new Vice President of Communications and Marketing, the CFO conducted an internal staff survey in early 2025 to assess communication needs. The resulting Internal Communications Plan was approved by the board in April and introduced to staff in May, with implementation beginning July 1.

Pursue National Accreditation with Council on Foundations

The CFO's Operations team began preparing for national accreditation with the Council on Foundations in early 2025. Weekly meetings serve to review required policies and documentation with submission completed in November 2025.

Review Fees Using Activity-Based Cost Analysis

An ad hoc committee convened in FY25 to review the CFO's fee structures using an Activity-Based Cost approach. The group's recommendations were approved by the board in October 2025, with communication and implementation scheduled to begin in early 2026.

Review Investment and Audit Services

The CFO's Investment Advisory Board completed its five-year review of Fiducient Advisors and unanimously voted to continue the relationship for up to five more years. The Audit Committee approved a new structure to separate tax and audit services. These updates reflect the CFO's growth and increasing operational complexity.

Donors expand annual Schweitzer grant program by \$94,000

From start to finish, the FY25 Jewell Schweitzer Collective Impact Grant Program was a celebration of collaboration — and a milestone in the CFO's ongoing shift towards transformational philanthropy.

Named after the late Springfield philanthropist, the program funded innovative solutions to community needs and required lead agencies to work with at least two other organizations. With \$120,000 initially available, the CFO's Community Impact and Donor Services teams invited families with donor-advised funds to support projects that aligned with their charitable interests. This effort resulted in five families recommending grants from their funds totaling \$94,000, expanding the grant program by nearly 80%.

"We're incredibly grateful to our donor-advisors for joining us to support innovative organizations that are addressing high-priority issues through collaboration," said Winter Kinne, president and CEO of the

Inspiring a more creative community in Ava

Art can build a creative sense of community and confidence, as demonstrated in Ava through a nearly \$10,000 Arts & Culture grant — supported by the Springfield Regional Arts Council, the Jeannette L. Musgrave Foundation and the CFO — to Living Lands Arts Collective to grow its current community outreach programming.

It's something that leader Jessi Eggleston says “completely shifted the way we plan” for the collective's future.

“This funding feels like such a powerful affirmation of what we've been working toward,” she says. “It not only validated our dreams in our own hearts, but it also showed our community that what we're doing is real, valuable and worth investing in.”

The center, located on the Ava square, opened in 2024. It's part pottery studio, part place for local artists to sell their wares, and part community space, with classes like basket weaving, doll making and embroidery. It's also a space that integrates inclusivity into its core mission, offering gatherings for sheltered workshop participants and other focused groups.

Those mission moments were supported by the grant, which also helped raise the bar in how the center works with professionals — paying them “fairly,” Eggleston says — and improve the standard of what the center offers.

“It's also helped us create consistency, which has helped us make some pretty big shifts in how we communicate with our clients,” she says. “Whether it's showing up regularly in nursing homes or keeping a steady schedule with our recovery groups, that reliability builds trust and deeper relationships.”

“Our teens now have structured opportunities that feel professional and meaningful, and our community members can count on us to deliver programs that are both healing and enriching. In short, the funding hasn't just expanded what we do, it's improved the quality of what we're able to offer in a way that makes us really proud.”

Donors direct \$24.5 million in grants to nonprofits

Of the variety of fund options provided by the CFO to help donors achieve their charitable goals, they boil down to two basic categories. Donor-advised funds allow individuals, families and businesses to set aside charitable gifts to grant them as needs arise with their preferred nonprofit agencies and causes. With designated endowments, donors specify the benefiting agency up front, then the CFO manages distributions from the fund to ensure long-term support.

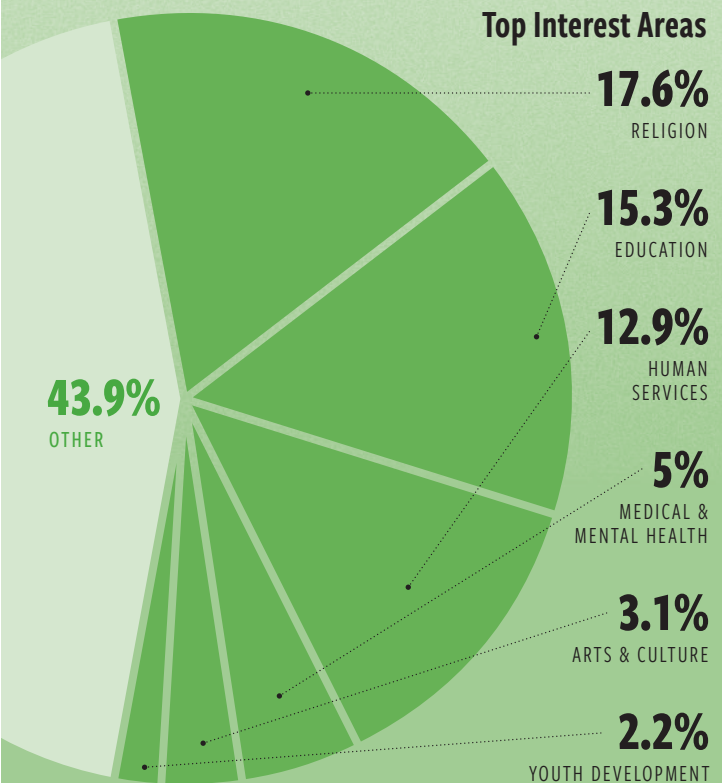

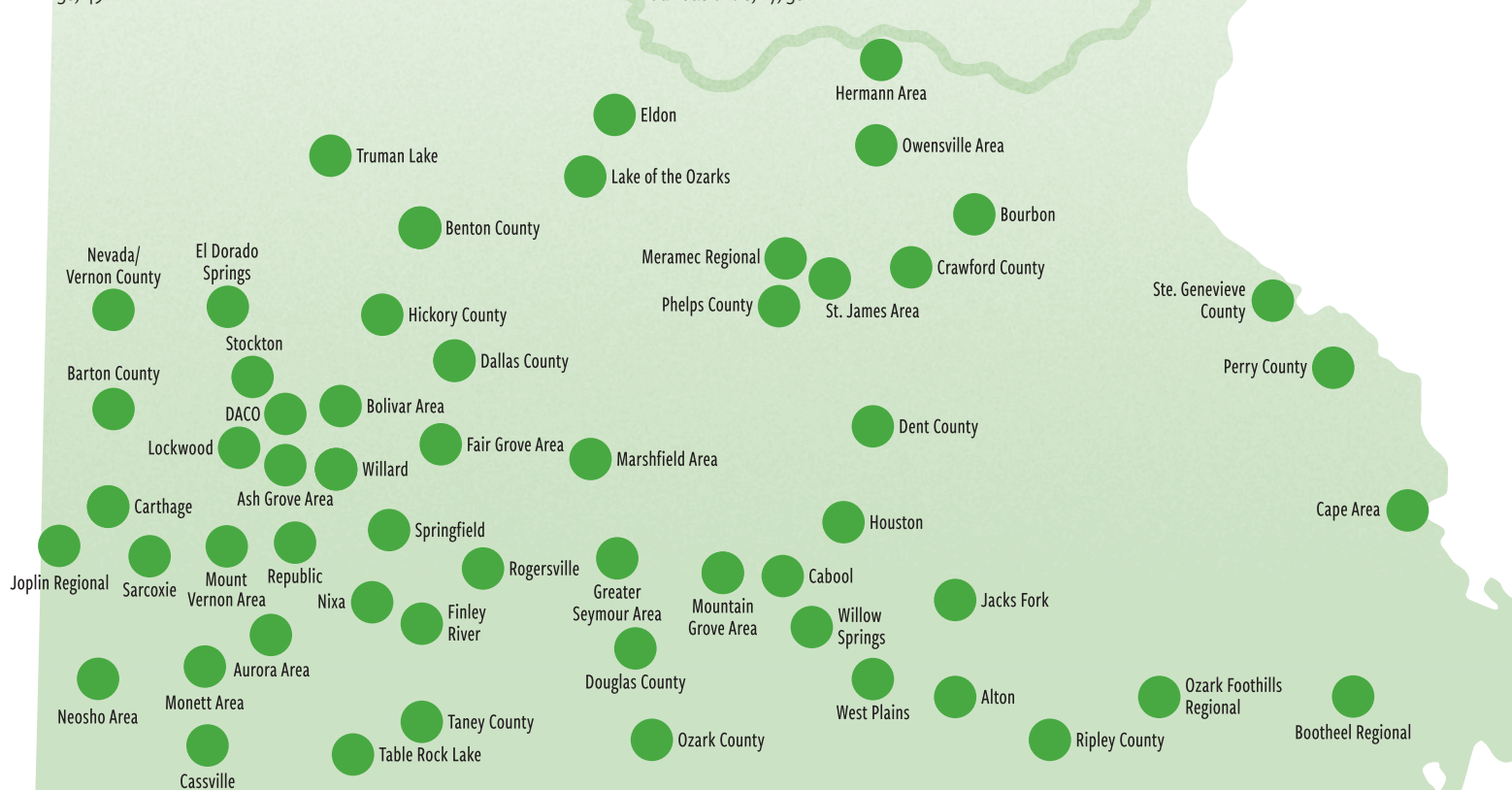

Scholarship program elevates nonprofit leaders

In March 2025, Network for Strong Communities celebrated its latest cohort of Capacity-Building Scholarship graduates — directors of several southwest Missouri nonprofits.

Based in St. Louis, NSC is a nonprofit that supports other nonprofits by providing affordable capacity-building services, strategic planning and education. In 2022, the CFO partnered with NSC to open an office in Springfield to serve CFO agency partners and other nonprofits throughout the region. The CBS program — exclusively for CFO agency partners — is part of that partnership.

The program began with a simple goal: “To give nonprofits the tools they need to take their impact to the next level,” says Nichole Hanna, NSC’s regional program manager.

For graduate Melisabeth Johnston of PFLAG Springfield/SWMO, the key was the Executive Director Roundtable. Despite the variety of organizations and missions, she says “our challenges and celebrations often mirrored each other. It was validating to know that leaders in other growing nonprofits had similar experiences, despite our differences.”

At the History Museum on the Square, Executive Director Sean FitzGibbons was navigating big changes — new facility, new staff, new vision. “This program enabled me to engage our board more effectively as we move to the future of the museum,” he says. “I will also take away a lot of tools that will help me motivate our team and navigate a lot of new processes as we move into the future.”

These experiences remind us that growth isn’t solitary work. Through customized workshops, peer mentoring and hands-on consulting, these leaders know they have gained skills, but they also know they have something just as valuable — community.

“What’s cool is seeing leaders from different organizations connect and collaborate in new ways,” Hanna says. “I think the crossing of ideas and experiences is going to lead to some really creative solutions and stronger leadership all around.”

The next CBS cohort begins its year-long program in March 2026.

Preserving community connections at Kings Prairie

Friends have gathered at the Kings Prairie Schoolhouse for more than 140 years. Thanks to folks today who want to see it stay, the small building will be restored — aided by a CFO fund and a grant from the Monett Area Community Foundation — and live on as a place to gather.

“The small communities were so integrated — we don’t have that anymore,” says Jaysa Isbell, a retired teacher who oversees the schoolhouse. “I hate to see it go by the wayside. It’s just a really neat building with a lot of history.”

The small building near Monett is the last in a line of Kings Prairie schools dating to the 1880s. The first, made of logs, was replaced by another that burned. Finally, the school standing came to be; it served kids until the 1960s, when it became a community center.

In the years since, it has hosted music festivals, visits with Santa, craft shows, seasonal markets and more — and remained a magnet for local memories.

“My father went to school there, and he was raised by an uncle who also went to school there,” says Noralee Faulkner, who attended Kings Prairie in the ’40s. “From the very beginning, there was someone in my family who went to school there. We kind of had a close bond to it for that reason.”

Even though she didn’t attend class in the current building, she still supports preserving the former school.

“I think it’s important because when our early settlers came here to settle the land, they really had no other means of support — this was going to be their life,” she says. “They valued education, and some had come from the East where they had fantastic schools. They wanted their children to be educated.”

Quilters build community stitch by stitch in Ozark County

Creating a sense of community can be as simple (and intricate) as quilting.

That's seen at the Ozark County Historium, where quilters bring their workbags, sewing machines and supplies every other Friday. They make progress on their own projects alongside friends found through common interest, who serve as a resource for those just starting out.

"Quilting offers something for everybody who loves to sew because you can hand quilt, you can piece, you can machine quilt, you can machine piece, you can do whatever you want," says Janet Taber, who helps lead the Historium.

Most of the original folks are still there, Taber says, and they've added others like Sheryl Kinsey. She started attending when searching for friends after moving to the Ozarks from Washington.

"I thought, 'I need to meet people,' so my ears were open," Kinsey says. "The gals were in here quilting and I lit up because I inherited two sewing machines and a serger and all kinds of quilting things. It's like I connect with my mom when I sew."

She quickly joined the group, and now her daughter attends too.

But the Historium — which holds funds with the Ozark County Community Foundation — is more than just a space for quilting. It's a place where a sense of community, so important in rural areas, is created.

The Historium hosts speakers, events and classes that highlight local culture. Volunteers assist visitors with local history and genealogy research.

Those collective efforts remind that traditions don't have to be "legacy" to be impactful. The Historium opened in 2011, and quilting began in 2017. Today, the Historium is a hub where friendships are found and fostered, and community is cultivated in an organic way.

To build community, one simply needs to find common interest — and make the first stitch.

Emilie Dickey

OCT. 18, 1929–MAY 7, 2025

Emilie Dickey and her late husband, John, were instrumental in the growth of the Marshfield Area Community Foundation and left a philanthropic legacy in the community. Through the establishment of the Dickey Family TLC of Marshfield Fund, John Wallis Dickey Family Foundation and The Dickey Administrative Endowment Fund, their cherished nonprofits and the wider Webster County area have benefited from their lives of generosity and understanding of endowments as tools for long-term impact. Emilie was a researcher, paralegal and teacher who loved traveling and spending time with her family.

Dr. Jerry Fankhauser

JUNE 19, 1944–MAY 5, 2025

Following a stint in the U.S. Coast Guard as part of the U.S. Public Health Service, Dr. Jerry Fankhauser opened a dental clinic in Springfield in 1969. Over his 45 years in dentistry, Jerry constantly sought to accomplish all he could for the community. He was a lifelong sports fan and sportsman, including a passion for sea diving. In 2017, Jerry and his wife, Leslie, established the Ben Fankhauser Sports Fund in memory of their son. Grants from the fund help junior high and high school students participate in team sports through the purchase of equipment and payment of fees.

Janice Gentile

JULY 14, 1948–AUG. 25, 2025

Jancie Gentile was a devoted career educator and advocate. Following her career start as a special education advocate and reading specialist, she served as director of Missouri Developmental Disabilities Protection and Advocacy Services, served under Gov. Kit Bond, and held other influential positions in the Capitol. After retirement, Janice championed numerous causes and, in 2002, helped establish the Community Foundation of the Lake, where she

was a longtime board member. In 2022 Janice and her longtime philanthropic partner, Lynn Griswold, established Branches for the Lake to promote economic development in the area. The CFL board has established a fund in Janice's name to support women, children and economic development.

Jack Kelley

AUG. 9, 1930–NOV. 18, 2024

As a lifelong Monett resident, Jack Kelley never stopped loving his community. The longtime co-owner and operator of KC Foam — later Crain Industries — Jack was a regular at the local golf course, a member of the Monett Presbyterian Church, and helped establish the high school's Quarterback Club to support sports programs. This love of community led Jack and wife, Darlene, to establish the Kelley Family Charitable Remainder Unitrust in 2004, an endowed gift that will support the Monett Area Community Foundation in perpetuity.

Francis Marion “F.M.” Pilant

JULY 8, 1941–APRIL 4, 2025

As a native of Clinton, F.M. Pilant cared deeply for his church and community in Henry County. A carpenter by trade, later in life F.M. went about building in a different way. In 2015, he established the Truman Lake Community Support Fund, a donor-advised fund that benefited local nonprofits through the Truman Lake Community Foundation. Hailed in his obituary as a “silent angel” who improved many lives in Clinton and the surrounding area, F.M.'s foresight and generosity will improve Henry County for generations to come.

Jan Robbins

OCT. 31, 1938–OCT. 22, 2025

After nearly a quarter century as an indispensable assistant to Springfield real estate developer and benefactor John Q. Hammons, Jan Robbins turned her skill for organization and passion for helping others into GYN Cancers

Alliance. As executive director for the Springfield-based nonprofit, she helped thousands of women battling gynecological cancers with GYNCA's support and care. As stated in her obituary, Jan's “work was a profound reflection of her belief that no woman should have to fight alone.” Her community impact also included stints on the boards of the OTC Foundation, Springfield Convention & Visitors Bureau and Springfield Area Chamber of Commerce.

Dennis Sheppard

JULY 30, 1950–SEPT. 19, 2025

For three decades, Dennis Sheppard served as general counsel for Springfield Remanufacturing Company and later as CFO and vice president of SRC Development Group. His time at SRC followed a lengthy career in corporate law in which he helped establish many local businesses. For more than 20 years, he served on the board of Burrell Behavioral Health, including a lengthy long stint as chair. In 2019, Dennis and his wife, Kathy, established the Dennis and Kathy Sheppard Family Fund with the CFO to assist in their family's charitable giving.

Robert N. Smith

JUNE 3, 1938–MAY 24, 2025

Bob Smith, though a native of Massachusetts, made a life in the Midwest. He earned his MBA from the University of Iowa before settling in Springfield. A longtime elder at First & Calvary Presbyterian Church, his volunteer activities included the Crosslines Toys Store, Scouting America and Big Brothers Big Sisters. In 2021, Bob and his wife, Henley, established a donor-advised fund to support their favorite causes. He was also a regular donor to the CFO's Founders Fund.

Past CFO Board Chairs

Roseann Bentley

APRIL 22, 1936–JULY 14, 2025

Roseann Bentley's lifetime of public service for the Springfield community and the state of Missouri has impacted generations of citizens and will continue to do so. From 1982–85, Roseann served as the first female board chair of the CFO, paving the way for other women to follow. Later, she was the first woman elected as state senator from southwest Missouri, serving from 1995 to 2003. In Jefferson City, she chaired the Senate Education Committee and Children's Services Commission, leading the effort for the state to fund Early Head Start programming. In Springfield, she helped found Ozarks Public Television, was the first president of the Junior League of Springfield and served as a Greene County commissioner from 2004 to 2016. She served as president of the Springfield R-12 Board of Education, the Missouri Board of Education and the National Association of School Boards. Roseann and her late husband, John, were influential local philanthropists serving on multiple boards and playing a part in establishing anchor nonprofits like Community Partnership of the Ozarks and Jordan Valley Community Health Center. Roseann was the Springfield Chamber's Springfieldian in 2003, and Roseann (2011) and John (2002) were named the Community Foundation of the Ozarks' Humanitarian of the Year — the only couple to earn the honor in individual years.



Dr. Kathleen Griesemer

JULY 20, 1938–DEC. 2, 2024

A Lawrence County native, Kathleen Griesemer moved to Springfield in 1959 after marrying her husband, John, and began a lifetime of work in service to the community. Among her impacts, she was a sixth grade teacher at Immaculate Conception School and, later in life, served as a licensed therapist for those experiencing chronic pain. Kathleen also served as board chair for John's company, Springfield Underground, from 1993 to 2008. Kathleen's passion for arts and culture led to her service on myriad nonprofit boards, including Springfield Art Museum, Springfield Little Theatre, Springfield Symphony and Springfield Regional Opera. Kathleen received the Child Advocacy Center's John Ferguson Award in 2016 and served in board and volunteer capacities for Springfield Catholic Schools. During the 2003 fiscal year, Kathleen served as board chair of the CFO and was a leading figure in the Philanthropy Initiative in the early 2000s, which greatly expanded the CFO's ability to serve regional affiliates. In 2006, she established the Kathleen Poirot Griesemer Charitable Fund.



Dr. Arthur Mallory

DEC. 26, 1932–NOV. 20, 2025

Dr. Arthur Mallory left a profound impact on nearly every aspect of Missouri public education. He is widely celebrated for his stints as the state's commissioner of education and as president of Missouri State University (then Southwest Missouri State College). But titles don't cover it all. The Dallas County native long served his hometown of Buffalo and was a member of the Dallas County Community Foundation board from its founding until his death. Dr. Mallory was a fierce advocate for rural education as a board member for the Community Foundation of the Ozarks. He served as board chair during the 2001 fiscal year, oversaw the hiring of CFO's second president Dr. Gary Funk, and was instrumental in the establishment and expansion of the Rural Schools Partnership.



Mary Kathryn Ashley Meek

MARCH 28, 1945–JULY 31, 2025

Mary Kay Meek leaves a legacy of generosity and service that shaped the Springfield community. Her education and life as a parishioner in Springfield's Catholic community, as well as her early career as a public school teacher, instilled a passion for people and service that led her, later in life, to stints as president or chair for a number of organizations. In addition to chairing the CFO board from 1990–92, Mary Kay led Junior League of Springfield, Greene County Board for the Developmentally Disabled, United Way of the Ozarks, Springfield Catholic School Board, Springfield Area Chamber of Commerce, Springfield Building and Development Corporation, and Jordan Valley Community Health Center. Mary Kay was named Springfieldian by the Springfield Area Chamber of Commerce in 1992, the first woman to receive the honor. In 1989, Mary Kay and husband Terry established the Terry O. and Mary Kay Meek donor-advised fund to aid their family's charitable giving. They were also contributors to the CFO's Founders Fund and members of the Funders Forum, a donor-education program.
